### 2. The social sphere

For ai crowd, s.r.o. respecting internationally recognized human rights is a basis for all business activities. It is mainly necessary to conform to these provisions and to the labour laws of the region in which the business partner operates.

- Working hours correspond at least to the relevant national legal standards or the minimum standards of the relevant economic fields.
- Respect freedom of association, and recognize the basic right of all employees to establish unions for employee representation, and to belong to them.
- Child labour is forbidden. Pay attention to the minimum employment age according to government regulations.
- Reject any conscious use of forced or compulsory labour, including debt slavery and forced prison labour.
- Adhere to applicable national occupational safety and health standards and within this context take appropriate action to ensure health and safety at the workplace, so that the work conditions do not threaten the health of employees.
- Ensure equal opportunity and equal treatment regardless of ethnic origin, skin colour, sex, religion, country of citizenship, sexual orientation, social origins or political convictions, as long as these are based on democratic principles and tolerance of those who think differently. As a matter of principle, employees are selected, hired and supported based on their qualifications and abilities.
- Apply a fair compensation policy without any sort of discrimination.
- Never tolerate any physical, mental or sexual harassment. Any form of abuse, humiliation, bullying, personal violation or discrimination is impermissible.


#### 3. Transparency and the business environment

- When importing and exporting goods and services, follow all valid, applicable laws.

The code reflects the general principles guiding business partners and suppliers in ethical conduct, but it is not intended to deal with every specific situation.


